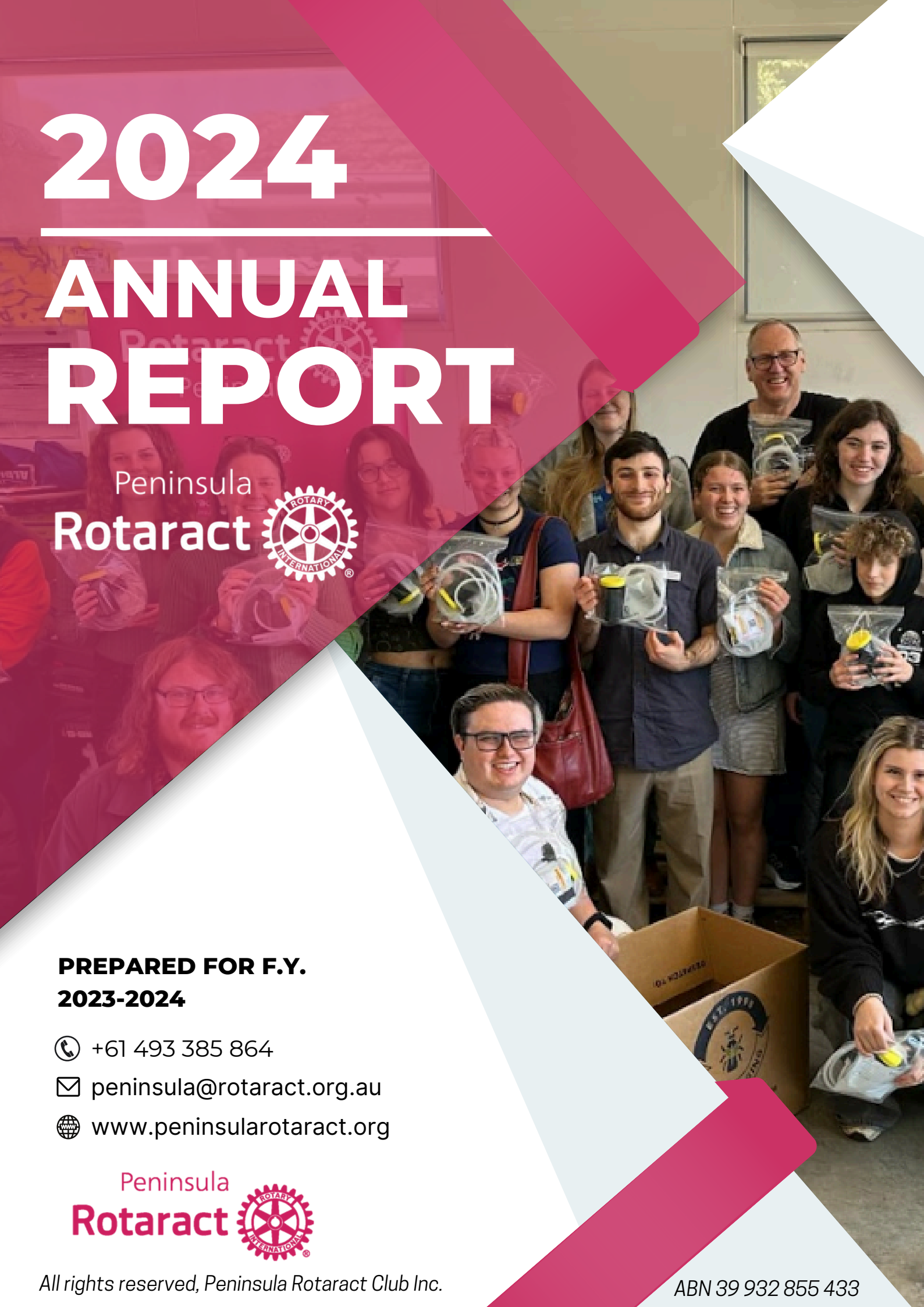

President

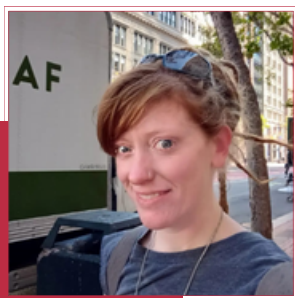
The President is the face of the club and the first among equals within the membership. The President chairs the organisation and ensures positive progress is being made towards our club's goals.

Vice President

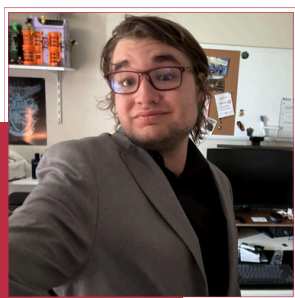

Treasurer

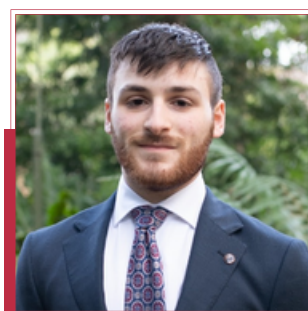

OUR PROJECTS

WESTERN PORT COMMUNITY SUPPORT TOY DRIVE

Over November and December 2023, our club raised \$1,677 through various fundraisers, which we used to purchase toys to donate to Western Port Community Support for young children in need at Christmas. This toy drive became the first project of our reactivated club.



DEVILBEND TURTLE GPS

In March 2024, our club committed \$800 to purchase a GPS for the Citizen Science Crew at Daangean, used to locate turtle nests and prevent laid eggs from being attacked by predators. During this project, we also launched a habitat island for turtles and shoreline birds.



CLUB RE-ACTIVATION

After a 3-year hiatus, Peninsula Rotaract appointed a new board in 2023, tasked with revitalising the club. Following COVID-19, the organisation was in a poor place, however with the dedication of our members, colleagues and supporters, we were able to re-activate the club, with a team intent on making it greater than ever before. Our reactivation efforts climaxed with our 're-founding ceremony' in April 2024, attended by various dignitaries from the local area and our Rotary District.
